# BACKGROUND

**May 2023:** Cordaid sampled some Districts from the 4 different regions of Rwenzori, Kigezi, Busoga and Elgon for a mini research to understand the Agri-food and Land tenure challenges affecting the small holder farmer and limiting the extension of services.

The research focused on the District Production and Marketing, Land tenure and General governance of the District services. District stakeholders shared their key challenges in these priority areas.

**Outcome:** The research supported the development of a proposal to the Embassy of the Kingdom of the Netherlands for strengthening the agri-food systems and land tenure in the 16 districts.



# AGRICULTURAL GOVERNANCE RESULTS IMPROVEMENT PROJECT (A-GRIP)

---

- **Align to government priorities e.g** The **National Vision 2040** aims to transform Ugandan society from a low-income to a competitive upper middle-income country within 30 years, **Maputo Declaration on the Comprehensive Africa Agriculture Development Program (6% agric growth rate)**. The aim is transforming the agricultural sector from subsistence farming to commercial agriculture
- **Linkage with EKN Projects – complementing the performance of the EKN funded projects in the region**
- **System strengthening Approach** - Address identified public challenges during project design

# OBJECTIVE OF THE A-GRIP PROJECT

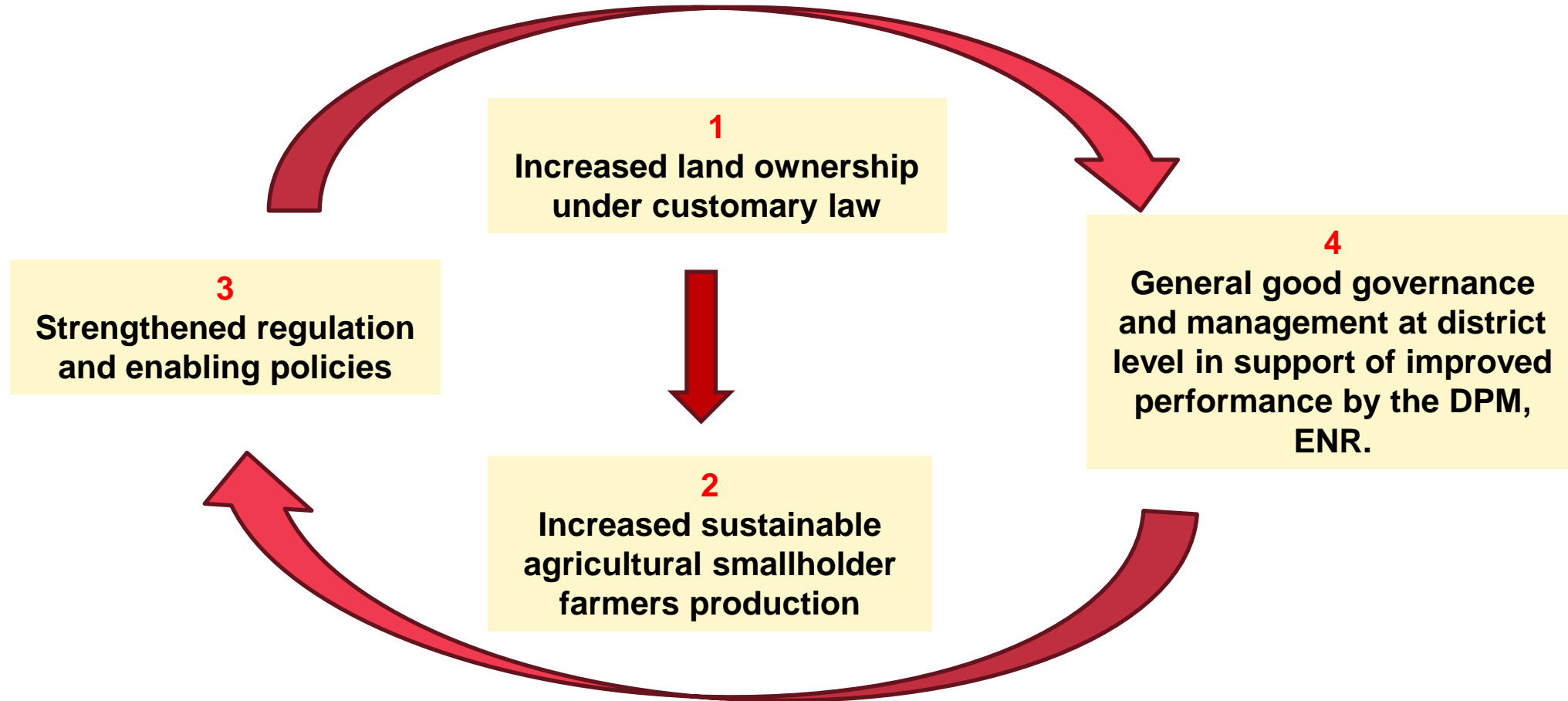


***Overarching objective:***

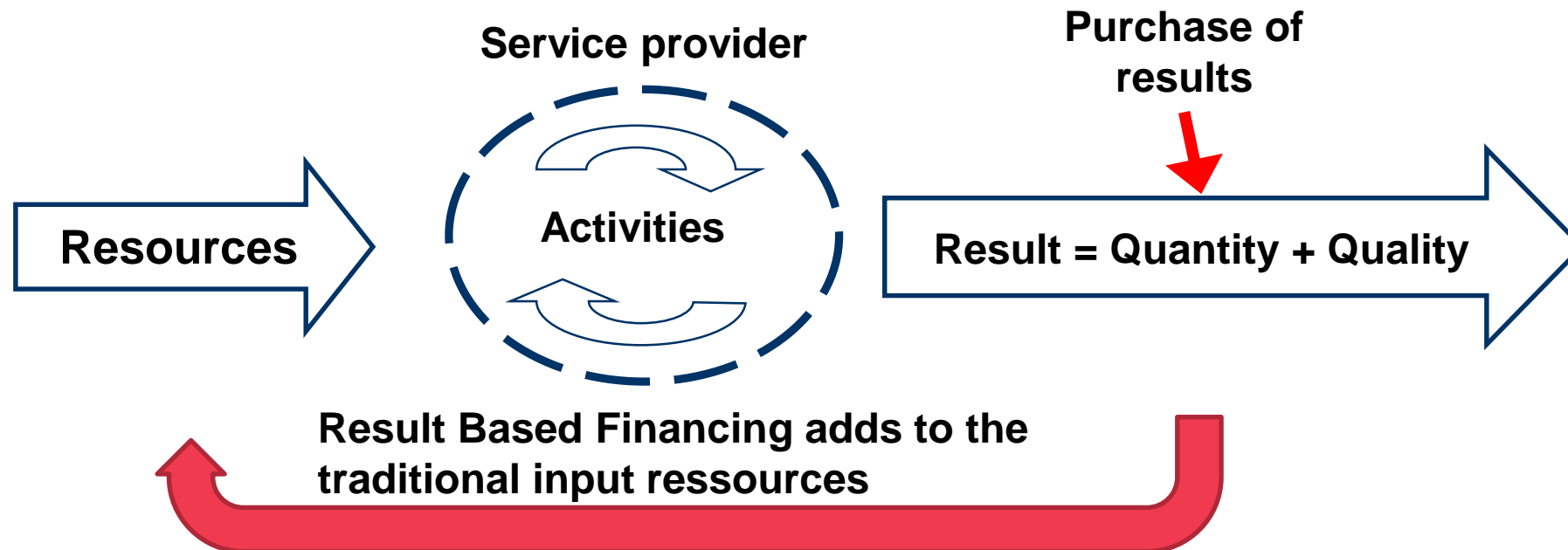


# RESULTS BASED FINANCING (RBF): system strengthening approach

## Definition

Results Based Financing gives (financial) rewards for the delivery of **predefined results** by **service providers**, upon the **verification** that the agreed-upon and reported performance/results have actually taken place.

RBF is an additional form of financing, on top of regular public **input** financing.



# OBJECTIVES OF RBF

---

Address basic causes of poor service delivery

---

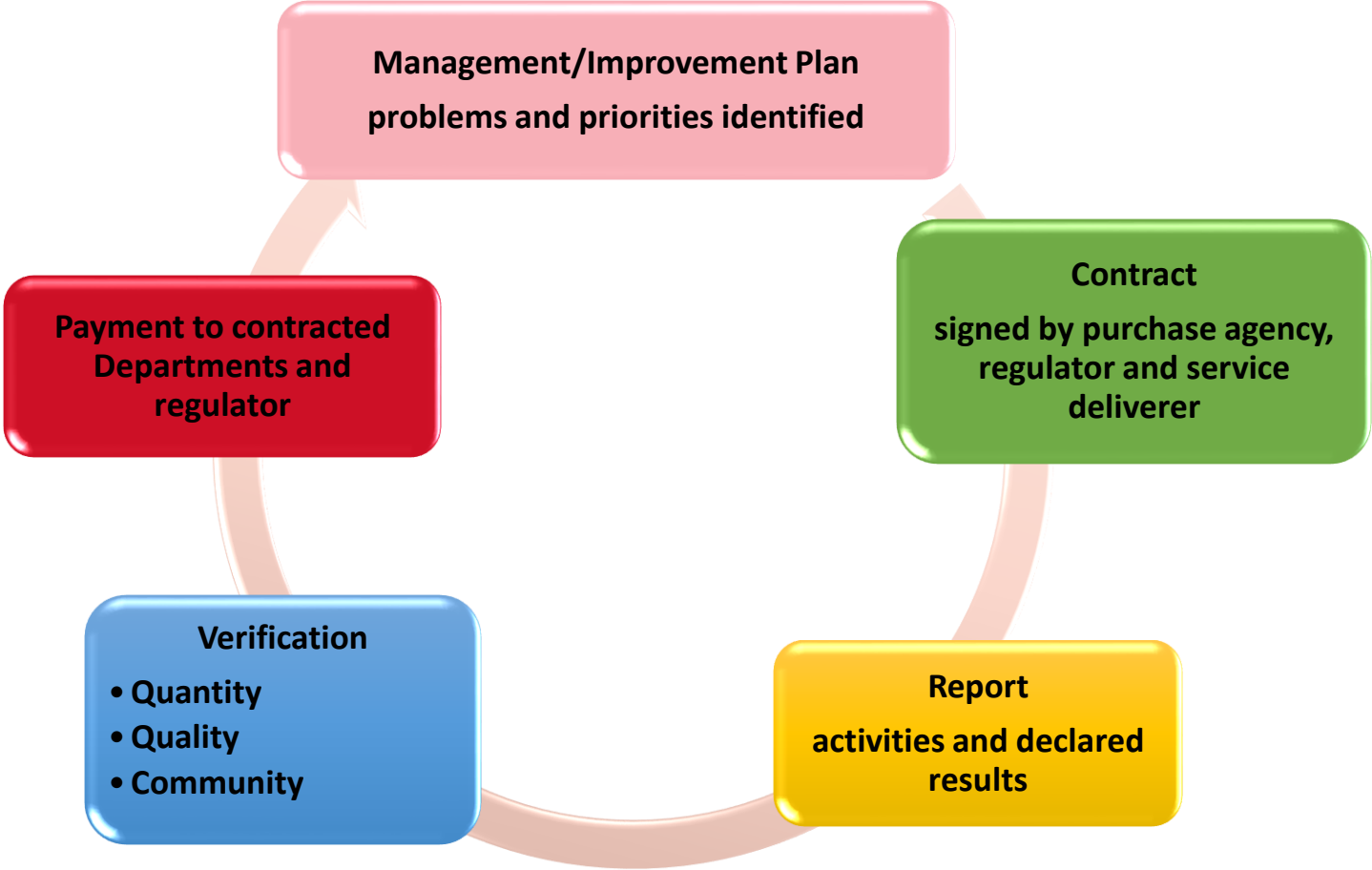
- Increase **Utilization** of services
- Increase **Quality** of services
- Increase **Reliability** of data (strict verification)
- Improve **Governance** through increased **Transparency and Accountability**

These objectives are achieved through addressing some basic causes or challenges of poorly functioning service delivery systems
