PUBLIC SECTOR TRANSFORMATION

Meaning of Public Sector

- Government and publicly funded agencies providing public goods, services, and programs.
- Characteristics of Public Sector
- Highly skilled people
- Weak performance and accountability
- Low work ethics and corruption
- Bureaucracy
- Inefficiency in responding to citizens' needs

THE NEED FOR PUBLIC SECTOR TRANSFORMATION

- Vision 2040 aims to institute measures to strengthen Public Sector management and administration by ensuring that the public officials are fully responsible and accountable for all the resources under their control.
- Additionally, sustainable development goal No. 16 calls for building capable institutions and transformed leadership at all levels.
- Therefore, the goal of Public Sector transformation is to improve the Public Sector response to the needs of the citizens and the Private Sector.

REQUIREMENTS FOR TRANSFORMING THE PUBLIC SECTOR

• People (Civil Servants): Accountability for work outcomes

 Leaders & Citizens: Demand for accountability and value for money

 Public Sector Infrastructure & Systems: Transparent performance measurement systems

 Resources: Adequate and efficiently deployed resources for effective service delivery

REFORMS IN PUBLIC SECTOR

- Structural adjustment programs: Downsizing and cost-cutting
- Reforms in Public Service, Public Finance, Anti-corruption, and Auditing
- Oversight bodies: Public Accounts Committee, Inspector General of Government, Auditor General
- Despite reforms, public sector still lacks accountability and effective response to citizen needs.

KEY CHALLENGES IN PUBLIC SECTOR TRANSFORMING

- **Budget Misalignment**: Disconnection between national/local budgets and results
- Weak Enforcement: Monitoring & evaluation reports not implemented
- Service Delivery: Standards not enforced across sectors like health and education
- **Corruption**: Ongoing challenge in governance
- **Resource Constraints**: Insufficient revenue and inefficient use
- **Talent Management**: Difficulty in managing skilled workers and low remuneration

INTERVENTIONS FOR PUBLIC SECTOR TRANSFORMATION

- Improved Accountability: Systems to ensure civil servants are accountable
- Better Leadership & Citizen Engagement: Encouraging demand for accountability
- **Resource Allocation**: Ensuring adequate resources are available and well-managed
- **Decentralization**: Strengthening fiscal decentralization alongside administrative decentralization

- **Definition**: The effective management of public resources and affairs in a manner that meets societal needs while using resources efficiently.
- **Importance**: Ensures accountability, reduces corruption, and promotes sustainable development.
